CIRCULAR

One post of Senior Stores Officer in the Level-11 in the pay matrix (Rs.67700-208700) is vacant in Indian Bureau of Mines under the Ministry of Mines and is to be filled up by Deputation including short term contract basis.

- O2. The Senior Stores Officer is responsible for Supervising all work relating to purchase of equipment and instruments listed in the Govt. input/UNDP Input in the project document for establishment and operations of Mineral Processing Laboratory Mining Tenament System/Remote Sensing Laboratory/Offices of Indian Bureau of Mines in India. He has to monitor work relating to inviting tenders/quotations for purchase of all equipment's instruments, Preparation of comparative Statement, placing of supply orders and making arrangements for coordinating with other agencies involved in inspection of these items. He has to make all necessary arrangements for receipt of these machineries/instruments, stock-taking, inventory, procurement of spares and accessories and day to day supplies. He shall be responsible for procurement through e-portals such as GeM, CPP etc. Also any other duties which may be assigned by the Superior Authority of IBM.
- 03. As per the Recruitment Rules for the post of Senior Stores Officer, the candidate to be considered for appointment by Deputation including short-term contract should be the officers under the Central Government or State Government or Union Territory Administration or autonomous or statutory organization or public sector undertaking or University or recognized research institution: -
 - i) Holding analogous post on a regular basis in parent cadre or department; or
 ii) With five years' regular service in the grade rendered after appointment thereto on regular basis in Level -10 in the pay matrix (Rs.56100-177500) or equivalent; and
 - (b) Possessing the following educational qualifications and experience:-
 - Master's degree with Economics or Commerce or Statistics or Business Studies or Public Administration from a recognized University or Institute;
 - Four years experience of indenting, purchase of technical stores and stores account in the Central Government or State Government or Statutory or Autonomous organization or public sector undertakings or University or recognized research institution. OR
 - Bachelors Degree in Economics or Commerce or Statistics or Business Studies or Public Administration as a subject from a recognized University or Institute:
 - Diploma in Materials Management or Warehousing Management or Purchasing or Logistics or Public Procurement from recognized University or Institute;
 - iii) Five years experience of indenting, purchase of technical stores and stores account in the Central Government or State Government or statutory or autonomous organization or public sector undertakings or University or recognized research institution.

- Note-1:- The departmental Officers in the feeder grade who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
- Note-2:- Period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or Department of the Central Government shall ordinarily not exceed four years.
- Note-3:- The maximum age-limit for appointment by deputation shall be not exceeding fifty-six years as on the closing date of receipt of applications.
- 04. The deputation period will be initially for 03 years and will be considered for further extension on the basis of requirement of this department and NOC from the parent department. However, the officer may also consider for pre-mature reversion to the parent cadre by serving 03 months advance notice to the parent department as well as to the officer in terms of provisions contained under DOPT OM No.6/8/2009-Estt. (Pay II) dated 17.06.2010.
- O5. Application containing the bio-data (in triplicate) of the officer who fulfills the above as on the closing date may be sent through proper channel addressed to **The Controller of Mines (P&C)**, 2nd Floor, Indian Bureau of Mines, Indira Bhavan, Civil Lines, Nagpur 440 001 in the enclosed bio-data proforma (Annexure I) within 60 days from the date of publication of advertisement in the Employment News alongwith the up-to-date Confidential Reports/Dossiers for the preceding 5 years, Integrity Certificate, Vigilance Clearance and No penalty certificate for preceding 10 years of the officer concerned. Applications received after the closing date will not be entertained. Also, advance copies of applications or not accompanied with all the above certificates/enclosures are liable to be rejected.
